TRIAL MEMBERSHIP TERMS AND CONDITIONS AS AT 1/10/24

- Membership rights for the term of Trial membership are the same as Ordinary membership, EXCEPT, no voting rights, cannot hold Office and ineligible to win Honour Board events
- Course access without any Green Fees while a Trial Member for social golf on any day and time outside scheduled competitions
- Opportunity to convert to either Ordinary, Seasonal or Lifestyle membership at expiry
- Any Trial membership option, including Christmas Trial can only be used <u>once</u> during a 3 year period
- Any historical handicap records in Golflink will remain as the members handicap, unless a review by Match Committee is required if that handicap no longer represents members ability for any reason
- New Australian Handicap will be issued, if there are no historical records, after 3
 x 18 hole or 6 x 9 hole cards are provided to Handicap/Match Committee
- Trial members may, upon invitation from the Match Committee, participate in any 9 or 18 hole competition prior to gaining a handicap
- Trial members may enter any Geraldton Golf Club Competition once a handicap has been gained and approval is held from the relevant Match Committee
- Access to Reciprocal Clubs is <u>not</u> available to any Trial or other Promotional memberships
- Past members can rejoin under Trial Membership, subject to approval by the Membership Sub Committee
- 3 x discounted Green Fee vouchers for use by your family or friends
- Lessons with resident PGA Professional included in any Trial membership must be taken prior to expiry of membership or will be invalid
- Trial membership to be paid in full in advance, no monthly debit option
- If conversion to Ordinary or Lifestyle membership does not occur upon expiry of Trial membership, then member is considered to have resigned and all records will be made 'Inactive'. Future course access would be subject to payment of standard Green Fees.
