Affiliated Agreement

This agreement for affiliation rights is made **between:**

ROYAL FREMANTLE GOLF CLUB of 359 High Street, Fremantle, WA, 6160

AND

GERALDTON GOLF CLUB of 30 Pass St, Wonthella WA 6530

- A. Royal Fremantle Golf Club and Geraldton Golf Club agree to grant access rights for the benefit of each other's members.
- B. The affiliated rights shall always be subject to the Rules, By-Laws or other Rules or Regulations from time to time in force and effect at the Club that is being visited.

WITH THIS, IT IS AGREED:

1. An affiliated club member with playing rights visiting the other Club (a "visiting member") will be extended privileges to use the host club's course and facilities which are usually enjoyed by those members of the host club whose membership rights and privileges most closely approximate those of the visiting member.
2. A visiting affiliated member will be required to pay 50% of the equivalent visitor green fee as advertised at the Club.
3. At least 3 days prior to their arrival at the host club a visiting affiliated member must contact the host club and provide a letter of introduction from their Club confirming the visiting member's identity, membership category and status and their current handicap. Before using the host club's course or facilities confirmation of a suitable date and time for the visit must be confirmed.
4. Affiliated playing rights are extended to a visiting member who is visiting the host club's Capital city or on holidays. This excludes those members who are resident in the host club's Capital city.
5. The host club's rules and regulations will apply to the visiting affiliated member during the visit to the host club.
6. Subject to timesheet availability, each visiting affiliated member shall have the same rights to introduce guests as a host club member. Such visitors shall pay the member-introduced guest green fee.
7. Where a visiting affiliated member wishes to introduce one or more playing guests, prior approval by the host club's General Manager or Golf Operations Manager must be obtained. Should be limited to no more than 2.

8. When using the host club's facilities, purchases made by a visiting affiliated member must be paid for at the time of sale.
9. A visiting affiliated member can enter and pay the appropriate fee for competitions conducted by the host club but may not win significant club competitions (Board events and Monthly Medal events) or any perpetual trophy event at the host club.
10. Both Clubs reserve the right to limit any individual visiting member from excessive use of the host club's course and facilities which in principle is agreed as being no more than six rounds per year. In the first instance, any such situation should be brought to the attention of the reciprocity officer for each Club.
11. Groups larger than eight players (visiting affiliated members and their guests) will require preapproval by the host club's General Manager or Golf Operations Manager and are subject to timesheet availability.
12. This agreement may be amended with the approval of both parties and will be reviewed annually. Either Club may terminate this agreement by providing three months' written notice.
